Statement regarding REACH and CLP

EU regulation no. 1907/2006 and EU regulation no. 1272/2008

The backbone of Dana Lim A/S chemical strategy is to use European, reputable raw material suppliers. Through continuous dialogue we seek to ensure that our suppliers have the knowledge and expertise to comply with the relevant EU Regulations on chemicals - both the current and the coming chemical legislation since this is under constant development.

Dana Lim is primarily a downstream user.

This means that under REACH we are obliged to check and ensure that Dana Lim's usages and applications are considered and supported by our upstream suppliers of hazardous substances.

And that all substances used in our products are either registered under REACH or exempt from it.

However, most of our products are not hazardous and therefore not covered by the obligations mentioned above.

Furthermore, Dana Lim A/S is aware of ECHA's Candidate list with SVHC. We monitor updates and inclusion of new substances on the growing list. Our internal policy is to avoid the use of substances listed as SVHC in our products.

In very limited cases this is however not technically or economically possible. In these cases, we strive to bring the concentration below 0,1% in the end products. In the rare case a product contains >0,1% of a SVHC-substance this information is available in our safety datasheet, section 3.

We do not use substances that are subject to authorisation and/or restriction according to Annex XIV or Annex XVII of the REACH regulation, respectively. We follow the assessment and status of new substances that are affected by these obligations closely.

Since many of our products are sold to consumers and professionals with a wide dispersive use, Dana Lim A/S has an internal strategy to strive to avoid the use of substances in our products, which means classification and labelling according to the CLP Regulation.

If a substitution or a reduction of concentration of substances, which lead to CLP classification of our products, is not an option, we try to obtain as low classification as possible.

Our Research and development department is continuously working to ensure, that Dana Lim's portfolio enables sustainable choices for our customers to be part of a more circular economy and future. This requires products without hazardous and problematic substances.

Safety datasheets are our main tool to communicate and pass along all relevant information on conditions of safe use for our products in the supply chain. The datasheets are generated in a SDS authoring software, which ensure the compliance with the current requirements under REACH, CLP and relevant national legislation in the countries where we market our products.
